
A one-stop shop for all your business needs

Roughly six and a half million people live in the eight federal provinces, regions and counties that make up the Central European Region. The position of the region at the intersection of four countries and four languages – the interface of the "new Europe" par excellence – is reflected in the great variety of Centrope partner regions and cities.



Project Centrope Capacity

Centrope Capacity is a project funded under the EU programme CENTRAL EUROPE. In the period until 2012, it will create a multilateral, binding and sustainable framework for the cooperation of local and regional authorities, enterprises and public institutions in the Central European Region.

To render Centrope more tangible, the main focus of Centrope Capacity is on the introduction of practiceoriented cooperation activities, which may be cooperative business ventures, joint projects of research institutions and innovation centres, the development of common tourism services or cross-border agreements on spatial and traffic planning.
